REPORTS:

1. Commissioner Gilmore's Report - Commissioner Gilmore gave a summary of police activity during the previous month. There were 45 adult arrests of for various crimes and 2 juvenile arrests. There were 43 warrants served with a total of 272 total calls for the month and 3409 year to date.
2. Commissioner Greenwald's Report – Commissioner Greenwald reported that there was a total of 97,060 pounds of single stream recycling handled along with 2,200 pounds of metal recycling. In addition, 171.69 tons of trash was collected as well as 12 cubic yards of brush. A total of 16 permits were issued during December totaling \$1,678.00 and a total of 229 for the full year for a total of \$64,722.00.
3. Engineers Report – Borough Engineer Joseph Federici reported that bid specs have been prepared for improvements to the Harding Avenue Pump Station and are ready to be advertised. Work on the re-construction of Cedar Avenue will also take place in 2009.
4. Mayor's Report – Mayor Wolk indicated that the Tax Collector reported a total of \$1,152,063.02 was collected through the Tax Office during the month of November for tax and various miscellaneous accounts. He also indicated that the Chief Financial Officer reported a total of \$1,452,042.04 was on hand as of December 31st.
