**REPORTS:**

1. Commissioner Gilmore's Report – Commissioner Gilmore read the monthly reports as submitted by the Fire and Police Departments (reports attached). He added that as we July 4 is a joyous time of year but added that with July 4 comes fireworks and they are illegal and the PD will be cracking down on that. On behalf of himself and his wife he wishes everyone a happy, healthy and safe July 4 celebration.
2. Commissioner Greenwald's Report – Commissioner Greenwald reported that single stream recycling in May was over 103,000 pounds which is 20,000 more than last month and really helps with trash costs. There were no accidents or injuries for the past month which reflects a safe month for DPW workers. In the Messenger it was reported that grass collections will be Thursday instead of Monday because of the July 4 holiday. From the Construction Department, permits issued were eleven for total fees of \$1201.00. On June 20, which was partially rained out and held again on June 27, the Celebrations Committee held the second annual children's fishing tournament. 35 kids showed up and a good time was held by all. He wished everyone a safe and happy July 4.

Engineers Report – Joe Federici reported on the following:

- Cedar Avenue project—pre-construction meeting was held and work will begin July 13.
- Streetscape Phase III, funding applied for through the Transportation Enhancement Act Stimulus Funding—we are still waiting to hear if we were awarded these funds and also for Phase II.
- ThMunicipal Aid applications for 2010 were submitted for Delaware and James Avenues.

3. Mayor's Report – The Mayor read the Tax Collector's report and a total of \$1,419,226.83 was collected during the month of May for tax and various miscellaneous charges (copies attached). We also had lien redemptions for a total of \$642.52. The Mayor also reported that in the Messenger was an item about Project Porchlight. This will be Saturday, July 18 from 10am-2pm and is a program to encourage residents to switch to energy efficient light bulbs. Volunteers will distribute free CFL bulbs to residents in the Borough. We need 30-50 volunteers. He then wished everyone a safe and happy July 4.

Mayor Wolk opened the meeting to the public and asked that residents state their name and address for the record.

John Blagojevich, 423 Garfield Avenue, stated that this was his first commission meeting and he hopes to attend more in the future and have a little input.

Mayor Wolk reminded the audience that the next workshop meeting will be July 26 and the regular meeting will be August 6.

Seeing no further public comment, on a motion by Commissioners Greenwald and Gilmore, the meeting was adjourned at 8:22. Happy 4<sup>th</sup>!
