On a motion by Commissioner Greenwald, second by Commissioner Gilmore, the mercantile licenses were approved with all in favor.

REPORTS:

Commissioner Gilmore read highlights from the Fire Department and Police Department monthly reports for May. He added well wishes to Officer Schaffer who is recovering from a broken knee.

Commissioner Greenwald read the construction permit report for May. In DPW, there were again no accidents or injuries. Single stream recycling was over 96,000 pounds. DPW repaired potholes, handled five sewer calls, had pump station cleaned, planted flowers and put up American flags for Memorial Day, installed the right-turn only signs on Fourth Avenue among other things. We received a letter on May 17 that commended Mr. Ken Jones for his help with a tree limb that fell causing a potential hazard. The resident reported it to Mr. Jones and within ten minutes they arrived at his property to take care of the limb. The resident, Carl Ingram, thanked Ken and Jim for their very quick response and help with this potential hazard.

Engineer Joe Federici reported that their office is preparing the plans and specifications for the Hartka Avenue project which is being funded by a DOT grant and that the project should be done this summer.

Mayor Wolk read the receipt totals from the Tax Collector report for the month of April, 2011. He added that our next commission meeting would be July 7. The July 4 parade will begin at noon. Mayor Wolk also thanked MEPRI for use of their hall for the June 7 primary. He wished everyone a safe and happy Fourth of July.

PUBLIC PARTICIPATION:

Mayor Wolk opened the meeting to the public and asked that residents state their name and address for the record.

Diane Vilardo, 11 Lincoln Avenue, asked about the resolution that pertains to Assembly Bill A-3285. Clerk Shannon explained that the pending bill requires that we advertise our projected costs for any projects for which we are advertising for bids. By advertising our projected cost, bidders don't have to sharpen their pencils and will know what our planned budget is and this is not in our best interest.

Theresa Ingram, 15 Second Avenue, asked how we are covering with Officer Schaffer out. Commissioner Gilmore explained that we use part-time officers as well as help from the Detective Sergeant and Captain. No overtime is incurred. Theresa added that the employees of Jersey Girls are coming out at 5am and make a lot of noise while residents are sleeping. They don't want to make a big deal out of it but would appreciate some help with this. Mayor Wolk asked that they keep us informed about any problems and we will address them.

Chief Dobleman reminded that the new left turn onto the Black Horse Pike from Fourth Avenue is now in effect. Also, they received information today that the plane that landed on the Hudson will be coming through Mount Ephraim on Monday on its way to Delaware. This will be the fuselage on a flatbed and hopefully will not cause too much of a traffic problem.

On a motion by Commissioners Greenwald and Gilmore, meeting was adjourned at 8:20pm.
