RESOLUTION OF THE BOROUGH OF MT. EPHRAIM, COUNTY OF CAMDEN AND STATE OF NEW JERSEY AUTHORIZING AGREEMENT FOR USE OF FIELDS

WHEREAS the County of Camden (the "County") wishes to perform dredging work within the Borough of Oaklyn ("Oaklyn"); and

WHEREAS the County intends to stage their equipment on sporting fields currently used by the Oaklyn Cougars youth football league; and

WHEREAS the County wishes to relocate the Oaklyn Cougars football practices to the Mount Ephraim Youth Athletic Association ("MEYAA") Little League Fields located in the Borough, comprised of the Major League Field at 98 Valley Road, Senior Field and the Little League Complex both located on Carlisle Road (the "Fields") in a manner that does not conflict with fall baseball within Mt. Ephraim; and

WHEREAS the Governing Body of the Borough of Mt. Ephraim has determined that the Fields can be used by the Oaklyn Cougars in a way that does not interfere with youth sports within the Borough, and that the County will, in exchange, may provide permanent lighting to the Minors Field; and

WHEREAS the Governing Body and the County are currently preparing an agreement for usage of the Fields;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Borough of Mount Ephraim, County of Camden, State of New Jersey, does hereby approve the attached "Agreement for Use of Field," or as it may be amended, and it further authorizes the Mayor or his designee to execute said Agreement and such other documents related thereto in connection with the foregoing.
