MEETING CALL TO ORDER/OPEN PUBLIC MEETINGS STATEMENT

Mayor Tovinsky called the meeting to order at 7:07pm with the "Pledge of Allegiance". He announced that this meeting was posted in accordance with the "Open Public Meetings Act" and proper notice of this meeting was made.

The Clerk called the roll with Commissioner Wolk and Mayor Tovinsky present. Commissioner Gies was absent with prior notice due to illness. Also in attendance for the Borough were Clerk Shannon, Solicitor Justin Strausser and Engineer Greg Fusco from KEI Engineers.

REPORTS AND COMMENTS BY COMMISSIONERS

Due to Commissioner Gies' absence, Chief Conte read the Mount Ephraim police report for December. They had 548 calls, made 42 car stops, issued 56 motor vehicle summonses, served 12 warrants and had 31 adult arrests for the month and he read the charges for the arrests.

Engineer Greg Fusco reported they are waiting to hear from DOT for authorization to advertise for bids for the Harding Avenue improvements. They will be submitting a grant application to DCA on January 20 for improvements to recreation facilities. He wished everyone a Happy New Year.

Commissioner Wolk read the details from the Tax Collector's report for December 2022, reporting total receipts of \$179,958.14. We also had one lien redemption for a total of \$54,116.74.

Mayor Tovinsky read highlights from the Public Works report for December reporting single stream recycling was 91,560 pounds collected and trash tonnage was 173.36 tons for a cost of \$14,990.45. Public Works collected electronics, concrete and metal, and set-up for the holiday parade. Leaf collection has stopped so they must be bagged for trash. All equipment has been prepared for the snow season.

PUBLIC PARTICIPATION

Mayor Tovinsky opened the meeting to the public and asked that residents state their name for the record.

Present was Theresa Armbruster from Fourth Avenue. She thanked the police for the sign pole, now she is waiting for the sign. Chief Conte said Public Works will be installing the sign. She still wants a stop sign at Pennsylvania Avenue and is anxious to see the results of the speed survey. Mayor Tovinsky responded that we will take care of her as fast as we can.

Angelique Kappatos from Valley Road said she received a letter about Wawa going before the planning board on Monday. She is opposed to what they want to do on Valley Road. She asked if residents have a say. Mayor Tovinsky responded that any residents who wants to be heard will be heard. The board will do what is best for the residents. He added that he was told that starting this year, the county will allow speed bumps on county roads. Kappatos said she is concerned about the traffic coming in and out of the Wawa driveway and the backup at the light. Vasile Kappatos asked if he could photograph the plans and the Clerk responded that they will be posted on the website. Ms. Kappatos added that PSE&G left a mess on Valley Road after the work they did and she has cleaned it up twice. Mayor Tovinsky said he will have Jim Beebe contact them and if we can, we will run the street sweeper. Ms. Armbruster added that she believes that the reason the traffic is so bad on Fourth Avenue is also because of Wawa. Vasile Kappatos added that when PSE&G did the intersection of Valley and the Pike, they left a ledge there and when trucks hit it, it

is very loud. Chief Conte said they will be back to do the restoration—they wait 90 days for the ground to settle.

Seeing no further public comment, on a motion by Commissioner Wolk, second by Mayor Tovinsky, the public hearing was closed.

On a motion by Commissioner Wolk, second by Mayor Tovinsky, the meeting was adjourned at 7:30pm.
