New Jersey Plastics Advisory Council Report Released

As most New Jersey residents now know, legislation that prohibits the use of singleuse plastic and single-use paper carryout bags at stores and food service businesses became effective in May of 2022. Among its other provisions, the law called for the creation of a Plastics Advisory Council, whose mission was to investigate and report on the effectiveness of the single-use bag prohibition and other issues pertaining to plastic waste reduction and recycling. The Plastics Advisory Council recently issued its first-year report which not only highlights the success of the single-use bag prohibition, but also includes numerous recommendations to improve the effectiveness of the law.

The council reported that the law "had the direct effect of eliminating approximately 88 million single-use plastic bags from New Jersey's environment per month." The report notes that this figure is an underestimation of the true number of single-use bags eliminated. It also addresses numerous related issues that have arisen over the past year, such as the accumulation of reusable carryout bags by residents resulting from the increase in home and curbside delivery of groceries.

The council will continue its work on plastic waste reduction and recycling and is required by law to submit a follow-up report in 2024. The council's first-year report is available at https://dep.nj.gov/wp-content/uploads/pac-first-year-report-2023.pdf.

DEP Recycling Awards Program Now Open

The DEP is now accepting nominations for its annual recognition program celebrating excellence in recycling. This year's program features 11 award categories, including a new award category - Recycled Products Procurement Star – which recognizes any business, institution, government agency or other organization that has implemented a post-consumer recycled products procurement program or expanded an existing post-consumer recycled products procurement program. Such products are made with a percentage of recycled content material derived from goods that were used by consumers, collected and then recycled. Nominations are due by July 21, 2023. Did You Know...

- The French government is undertaking a major cleanup of the Seine River in the hopes of using the river for various aquatic events during the 2024 Summer Olympics in Paris. In addition to employing various strategies to improve the water quality of the Seine, the cleanup effort includes removing many tons of trash and debris from the river.

Truth in Labeling Basics

Understandably, consumers believe that a product or package is recyclable when they see the chasing arrows or any other indicator of recyclability on the product or package. Many of these items, however, are not accepted in local recycling programs and so become contaminants in the recycling stream once placed in a recycling bin. This confusing scenario has led many states to explore "Truth in Labeling" legislation, which makes it illegal to include the recycling symbol or an indicator of recyclability on a product that is not recyclable. Dual Stream Recycling Resource Now Available

In recognition of the renewed interest in dual stream collection of recyclable materials – bottles, cans and containers in one bin and paper in another bin - the DEP released a fact sheet on the benefits of this collection system. This system contrasts with single stream collection systems, which allow users to mix all recyclable materials in one bin.

While not financially or logistically feasible for all, stricter quality control standards, recycling market fluctuations and rising program costs have not only led some in the recycling community to reconsider dual stream collection of recyclable materials but to return to dual stream collection programs, which typically generate materials that are cleaner and more marketable than single stream collection programs.
